Over the decades, many actions have been taken to protect the environment. This has been accelerated since 2015 when the European nations decided to become climate-neutral by 2050: no greenhouse gas (GHG) emissions are to be emitted that are not otherwise compensated.

To reach this ambitious but necessary goal as part of every ESG roadmap and to drive forward environmental protection, all parts of society need to contribute and reduce their GHG footprint in gases with high greenhouse warming potential (GWP) factor.

Especially the fossil based industries – like oil, gas, chemical and petrochemical – are still responsible for a high amount of GHG emissions with a high GWP, foremost of all carbon dioxide (CO<sub>2</sub>) and methane (CH<sub>4</sub>) and their precursors – the volatile organic compounds (VOC) – that are created in many industrial processes.

Many initiatives have already been taken in the last years to reduce the industrial GHG footprint – the awareness for more environmental protection in the industry is constantly growing. However, much more must be done to reach “net zero” carbon dioxide emissions and to fulfill – among others – the Carbon Border Adjustment Mechanism (CBAM) for products by 2026. While more sustainability and environmental improvements are rigorously enforced by stricter international and regional regulations, the economic impact of not reducing GHG emissions increases in the coming years. By 2030, the price per ton carbon dioxide will double and will exceed 200 \$/t by 2040.

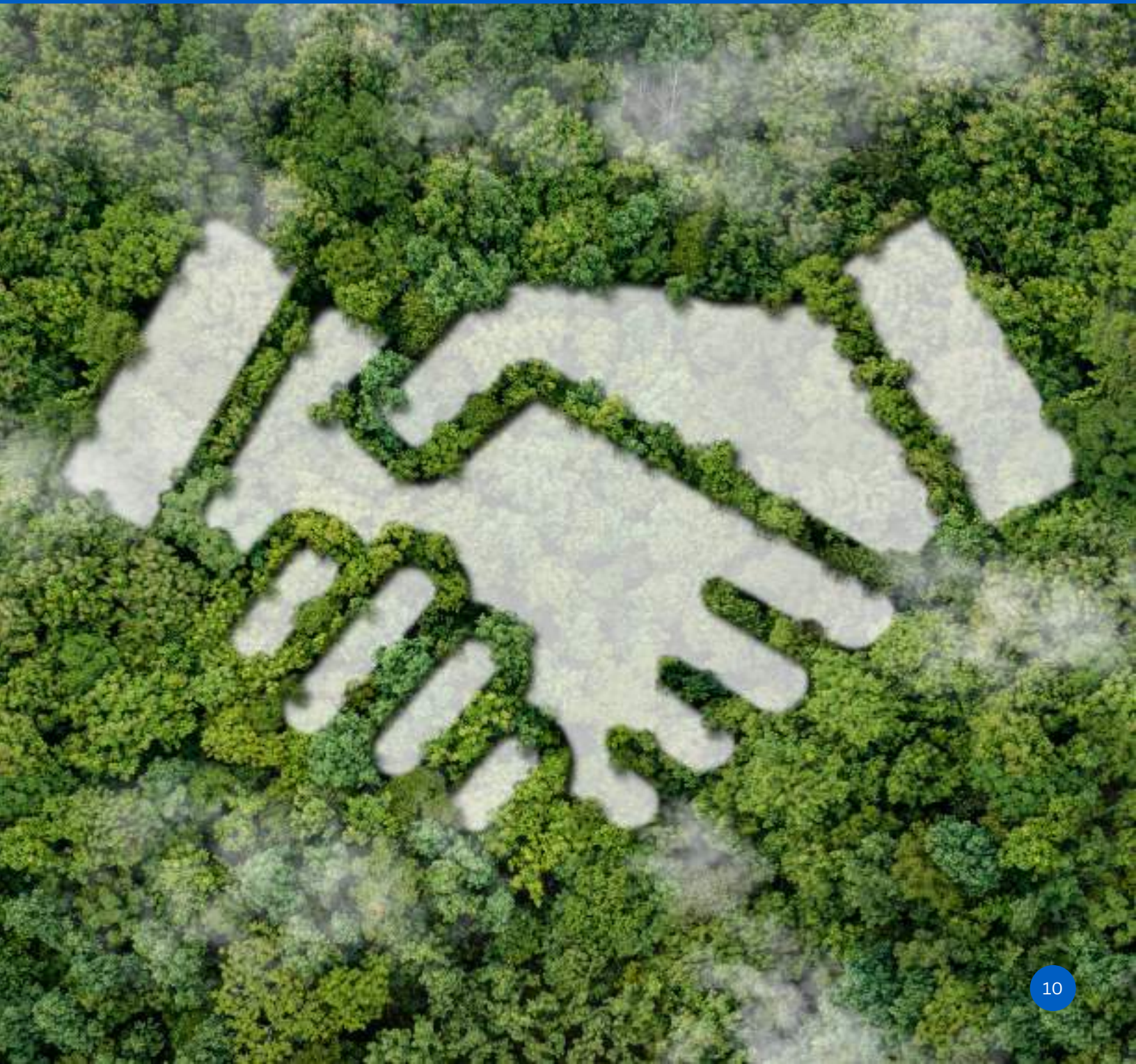
